### HSA Deceased Distribution

#### What to do when an HSA holder passes away

- 1. Beneficiaries of HSA holders should submit the <u>"HSA Deceased Distribution Form"</u> to UMB to get access to their HSA funds.
  - This is available on the <u>MyChoiceAccounts.com</u> / Learn More / Forms site.
  - Members can call: **866-520-4472** to speak with UMB about the process if needed.
- 2. Once UMB receives notification via the form, they pass info via file to MyChoice Accounts alerting us to liquidate any investments back to the cash portion of the HSA. We send UMB a nightly file of active investment balances to help them flag accounts that need action.
- 3. The form has additional information as to what is required, depending on the amount of the payout, the beneficiary type, etc. For example, if a payout is more than \$7,500, UMB may request the claimant send a certified copy of the death certificate, and copies of the claimant's driver's license or ID and social security card via mail.

## **Capturing Beneficiaries for HSA**

## Solution Adding a Beneficiary

#### HSA members should record a beneficiary (one or more) via UMB

HSA beneficiaries are not currently captured at the Benefitsolver level.

**Option:** Use the system level email + UMB form to capture beneficiaries at the member level.

#### **Current Process:**

- 1. Log in to your benefits portal at [[websiteurl]], navigate to **MyChoice Accounts** and select HSA from your account list.
- 2. Click on the **View HSA account number** button below your balance, then select the eyeball icon to view your HSA account number. You will need this to fill out your form.
- 3. Download the UMB Beneficiaries form here.
- 4. The form is fillable on your device. Complete the form, using your account number from the statement and your additional details.
- 5. Save and print.
- 6. Follow the form's instructions to mail or fax to UMB.
